

Arlington Thrive provided financial assistance to referred client cases through the Daily Emergency Financial Assistance Fund, Carter-Jenkinson Memorial Homelessness Prevention Fund, Permanent Supportive Housing Emergency Assistance Fund, Permanent Supportive Housing Maintenance Assistance Fund, the Risk Reduction Fund and the Arlington Thrive Fund which provides Covid-19 Related Assistance. Throughout the pandemic Arlington Thrive has served as the primary vehicle in Arlington County for emergency financial assistance for residents facing financial crisis and eviction throughout the COVID-19 pandemic. In addition to significant increases in local and Federal funding in 2020, Thrive also saw massive increases in support from individuals, businesses, faith communities, and foundations.
